## COF Addendum Reminder ([Office of the Registrar](#))

A [COF Addendum](#) is required for undergraduate, resident students paying in-state tuition who wish to add a class after the third Friday of the semester.

When you send a Special Action Form to the Office of the Registrar to add a student to a class, if the student is a resident undergraduate paying in-state tuition, you must also send a COF Addendum with signatures from both the student and a member of the department of the class. The form must include the reason that the student is adding a class late in the semester. A COF Addendum is required for late adds until the last day of the semester, Dec. 9, 2016.

NOTE: Sunset of the COF Addendum process has been delayed until Spring 2017.
