Sharon Matusik is the 14th Dean and Professor of Strategy and Entrepreneurship at the Leeds School of Business, University of Colorado. Having lived in many of the great entrepreneurship hubs across the country, Matusik brings innovation and a vision for positively changing the future of global business to her role as dean.

She is the type of leader who anticipates what resources and opportunities are needed to help students on their way to becoming the leaders of the future. She is sharply focused on engagement with business leaders and influencers locally and globally as a critical complement to academic excellence from the faculty in shaping the Leeds School experience. As a first-generation college student, Matusik is also a champion of diversity in business and education, as demonstrated by her efforts to recruit women and minority students and faculty to the Leeds community. Above all, Dean Matusik is someone who understands where the future of education is headed.

"The Leeds School has generated great momentum in such a short period of time," says Matusik. "Together our world-class faculty and staff and our forward-looking business and alumni community work to inspire and educate the next generation and make us a top business school."

- Serving as co-chair for the CU systemwide "Lean Into the Future" strategic planning efforts in 2019–2020.
- Overseeing Leeds' 4-year graduation rate increase to 77% in 2020 (nearly a 15% increase in three years), schoolwide career placement achieved 90% for the fifth year in a row, and notable rankings of the schools undergraduate and MBA programs: U.S. News & World Report ranked Leeds in their Top 20 Public Undergraduate Business Programs for 2020 and the Full-time MBA was named #15 in entrepreneurship by Bloomberg.
- Driving efforts toward cutting edge business research that is making a positive impact in our community and the world; Leeds faculty were named #24 in the world for per-capita research productivity by the University of Texas Dallas' research rankings.
- Growing the size of the research faculty by 30%, and increasing its diversity.
- Record-breaking fundraising and levels of business community engagement at Leeds.

Prior to becoming Dean of the Leeds School, Matusik served in a variety of leadership roles at the Leeds School — including senior associate dean for faculty and research, and academic director of the Deming Center for Entrepreneurship — and in her academic field.

Her teaching interests include strategic management, entrepreneurship, innovation and global business. She has taught strategic management and entrepreneurship extensively at the undergraduate, MBA, PhD and executive levels, and has taken groups of MBA students to visit and gain firsthand experience with an emerging economy, most recently to Cuba, to study the role of entrepreneurship and innovation in economic development. Dr. Matusik also spent a semester as a visiting professor at Universidad del Desarrollo (UDD) in Santiago, Chile — a leader in entrepreneurship in Latin America.

Before coming to Leeds, Dr. Matusik served on the faculty of the Jones Graduate School of Management at Rice University. Prior to entering higher education, Matusik worked in the consulting field.

Matusik's research areas of expertise are in corporate strategy, innovation and growth strategies, knowledge assets, venture capital, and entrepreneurship. Her work has been published in top international academic journals and is widely cited in the management field.

Matusik is also a leader in the local business community. She speaks regularly on topics related to innovation and entrepreneurship, and advises local entrepreneurial ventures. In addition, she serves as a board member for nonprofit organizations including the Strategic Management Society and University of Technology in Sydney, Australia.

She has also received numerous awards for her research, teaching and service to her profession, including the Rising Star Award from the Boulder Chamber of Commerce for her innovation and leadership in her first year as dean of the Leeds School, Denver Business Journal's Outstanding Women in Business award finalist, and the William H. Baughn Award for outstanding faculty service at the Leeds School.

Michael Conway was appointed as Colorado Insurance Commissioner by Governor Jared Polis on December 21, 2018, and was confirmed to this position by the Colorado State Senate on January 22, 2019. Prior to this, Conway served as interim Commissioner, a position he was appointed to by Governor Hickenlooper in January 2018. As Commissioner, Conway serves as the chief executive of the Division of Insurance and oversees the regulation of the insurance industry in Colorado. His role brings together consumers, the insurance industry and other stakeholders to create an inclusive, firm and fair regulatory approach to all lines of insurance such as auto, health, homeowner, life, property and casualty, title and workers' compensation.

Prior to his appointment, Conway served as the Division of Insurance Deputy Commissioner for Consumer and Compliance Services since March 2016. In this time, he was instrumental in developing and guiding the Division's strategies regarding health insurance during what was a tumultuous time for that industry in Colorado and the nation. He advised the previous Commissioner and the Governor's staff regarding the possible implications of federal changes to the regulation of health insurance here in Colorado.

Conway's duties also entailed appearing before state legislative committees to advocate for the Division's positions regarding insurance and its regulation. He cultivated relationships with consumer groups and the insurance industry to create a regulatory environment that helped Colorado consumers but was a fair, level playing field for the industry. He also worked within the Division to establish objectives that provided for better protection of insurance consumers.

Before joining the Division, Conway was an assistant Attorney General for the Colorado State Attorney General's Office from 2010 to 2016, where he represented the Division of Insurance in all facets of the regulation of the insurance industry including mergers and acquisitions of insurance companies, insurer rehabilitation/liquidation, and producer and company licensure litigation. He served three Commissioners of Insurance during that time. While in the Attorney General's Office, he worked with the Colorado Attorney General Pro Bono Family Law Clinic, advising clients on matters of divorce and child custody.

Conway has also worked as an attorney for Colorado Legal Services, advocating for indigent clients regarding housing rights, homelessness prevention, evictions and subsidized housing.

With the exception of three years he spent in Miami for law school, Conway has called Colorado home for nearly 20 years since moving to the state to attend the University of Colorado at Boulder.

At the core of Albus Brooks' identity is community development and servant leadership. Albus moved to Colorado in 1997 to study and play football for the University of Colorado. Sports Illustrated named him one of the Top 10 Hardest Hitters, and the NFL took interest in him before injuries ultimately ended his football career.

Albus Brooks pursued his calling for community development by working with young people in Denver's poor communities. He served as the Director of the Issachar Center for Urban Leadership, an organization that invests in Denver's emerging leaders. In 2010 Albus worked to elect then Mayor John Hickenlooper as Governor of Colorado, acting as the statewide Outreach and Political Director.

This exposure to political leadership led him to seek public office, and in 2011 Albus defeated 38 opponents to become the youngest African American ever elected to Denver City Council. Serving two terms on Denver City Council, including two terms as Council President, Albus accomplished an ambitious range of progressive legislative victories with the goal of building a truly inclusive city. To address the affordability crisis, he cocreated Denver's first — and Colorado's largest — affordable housing fund. To make Denver a more equitable place to grow up he funded and expanded the Denver Preschool Program, providing universal access to preschool for all 4-year-olds.
