Master's Thesis Plan Form

Upon admission, master's students are set up with non-thesis plan milestones. Students who are pursuing a thesis plan should complete this form in order for their records and milestones to accurately reflect their plan. The form should be submitted as early in the student's career as possible. At the latest, the form must be submitted by the deadline to apply to graduate in the semester in which their degree will be awarded.

Note that thesis paln students register for 4-6 master's thesis hours (9 for CRWR MFA students), conduct a thesis defense of 3 committee members, and submit a written thesis through ProQuest. Students who are pursuing a creative thesis, project, music thesis project, portfolio, or other type of culminating activity are not considered to be thesis plan students, and need not fill out this form.

The landing page includes helpful information for students:

Master's Thesis Plan Information

Students completing a written thesis as part of their Master's degree program must submit this form so that their record can accurately reflect their plan and associated requirements. Students pursuing a thesis plan will also register for Master's thesis hours as appropriate and complete a thesis defense. Work closely with your department to determine the minimum and maximum thesis credit hour requirement for your degree.

The form should be submitted as early as possible in a student's career, and at the latest should submit it by the deadline to apply to graduate for the semester in which the student plans to earn the degree. Deadlines and thesis information can be found on the Graduate School's website.

Note that students completing an art practices MFA creative thesis, music thesis project, or dance MFA project do not submit a written thesis and need not complete this form.

Endorsements Needed

The graduate program must endorse the form.


Information Needed

Students will provide their name, CU e-mail address, student ID, and select their program on the landing page. On the form, the student should read and sign the form indicating that their master's degree will include the submission of a written thesis.


Submission & Routing Information

Students will receive notification upon submission, and the Master's thesis plan form will be sent to the graduate program for endorsement. After review by the Graduate School, the student and program will receive notification.

On the landing page, the student will enter their name and colorado.edu e-mail address.



After clicking next, the student must select their college and then expand the college with plus symbol to select their graduate program.



The student will be directed to the form, where the name, program, and e-mail will populate from the landing page. The student should enter their student ID number and sign the form, after reading the information to ensure that the form is appropriate to their degree plan.
