Who is eligible?

University of Colorado Boulder graduate students with a graduate appointment of 20% or greater and graduate students on select full-year “full-ride” fellowships will be automatically enrolled in the plan once their appointment is entered by their employing unit. Notification of enrollment will be sent directly to students within 5 business days of the information being entered. If students do not receive notification of their enrollment they should first check with their employer to make sure the position has been entered correctly and to verify that they meet the criteria for eligibility.

- **Sydney Health app.** Find dentists in your network and view your claims right from your mobile device.
- **Dental care cost estimator.** Look up costs for common procedures and treatments from dentists in your plan network, so you know what to expect.
- **Ask a Hygienist.** A licensed dental professional will answer your questions via email within about 24 hours.
- **Dental health risk assessment.** This quiz can help you better understand your oral health and risk factors for tooth decay, gum disease, and oral cancer.
