

Online Program Approval & Administration Rubric

This rubric is designed to facilitate decision making for new academic degree and certificate programs offered by CU Boulder. (Exceptions are noted.)

There are three options for academic programs. Based on the program components, the academic program will be assigned to Boulder Main Campus, Boulder Continuing Education or Boulder on Coursera. It is possible for degree programs to be offered on more than one of the three campuses, but the curricular requirements and credentials are expected to be largely the same.
