Course Objective:

This course examines the major actors and institutions of criminal justice: police, prosecutors, defense attorneys, plea bargaining, criminal, civil and juvenile courts, sentencing, incarceration and community supervision. We will also focus on how institutions of criminal justice discover, respond to, and process crime as well as discuss some of the problems within the criminal justice system

Exams
