

If you add or drop courses after we have already submitted certification requests for you, we will have to adjust all of your submissions for summer. This could cause you to receive debt letters for some terms or additional payments for others.



You need to be enrolled MORE THAN HALF TIME to receive *any* Housing Allowance, and the VA will prorate from there to Full Time status. This means you have to be full time for each summer session or combination of overlapping sessions to receive full housing all summer. The VA considers everything with different session dates a separate term. You must be enrolled in an In-Person course each day you wish to receive the in-person housing rate. If you are in online classes only on any given day, your housing rate will revert to the online rate on that day.
